the above Rural Water District, hereby submits a \$100.00 deposit and makes
application to said District for water service, and agrees to the following
conditions:

- 1) The deposit hereby submitted is non-refundable. If water service is approved, applicant agrees to the following:
- 2) Within one year of approval of this application, to purchase or cause to be purchased one benefit unit at the unit price of \$3,000.00 (\$3,000.00 less \$100.00 the application deposit = \$2,900.00 for a balance due).
- 3) Within 60 days of completion of installation or 30 days of invoice date, pay for all cost to extend pipeline from the districts' existing facilities to the location of service.
- 4) Pay the minimum monthly charge from time service is made available by the district, and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum monthly water charge and rate schedule enacted by the Board of Directors of the district shall become a part of this agreement as though fully set out herein.
- 5) The undersigned agrees to not make any physical connection or arrangement in their piping system whereby there may be a flow of any unknown or harmful substance into the district's water supply system, or make any physical connection between any private water system and the water system of the district. Representatives of the district may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision and other purposes necessary to perform the duties of the district. Violation of this provision shall be grounds for disconnection of service.
- 6) The laws of the state of Kansas, the By-Laws of the district, and the Rules and Regulations of the district, as presently existing and as may be amended from time to time, are made a part of this agreement as though fully set out herein.
